- 19 renewal fee established in paragraph (a) of this subsection;
- 20 (2) Duplicate license: twenty-five (25) dollars.

- 2 (4) Reinstatement fee:
- 3 (a) Within thirty (30) days of expiration: 120 percent of the active
- 4 license renewal fee established in subsection (1)(a) or (1)(b) of this section;
- 5 (b) Between thirty-one (31) and sixty (60) days of expiration: 140
- 6 percent of the active license renewal fee established in subsection (1)(a) or
